- Our organization provides donors with flexible, efficient, and tax effective ways to ensure their charitable giving achieves the greatest possible impact.

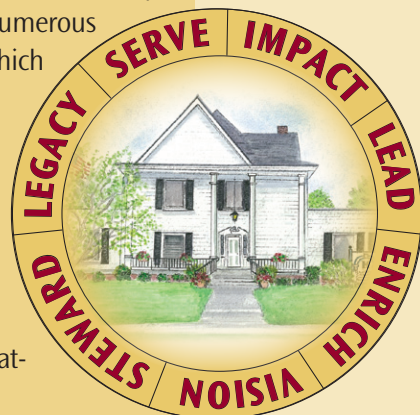

and operating support for this community and the organizations that serve its people. Additionally, more than \$327,000 in scholarships awarded, including the Lilly Community Scholarships, helped over 110 students continue their education.

Throughout the past two years the Board of Directors of the Hancock County Community Foundation has focused on growing the Spirit of Community funds (page 19). 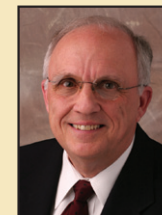

KENNETH BUTLER MEMORIAL SOUP KITCHEN

In 2010, Kenneth Butler Memorial Soup Kitchen was the proud recipient of two grants from the Hancock County Enrichment Fund. From the grant money awarded, the kitchen purchased a portable wheelchair ramp to allow individuals who might otherwise be unable to access the building, to obtain meals. Many of the kitchen's patrons are in wheelchairs and the new ramp makes access to the facility much easier. The ramp also confirms the kitchen as ADA (Standards for Accessible Design) compliant. In addition to the ramp, the kitchen also purchased painting supplies with support from a second HCCF grant made to them in the fall of 2010 to create an environment where the walls are easy to clean and patrons feel welcome.

Since the Soup Kitchen opened its doors to the public on October 12, 2009, it has served over 20,000 meals to residents of Hancock County, the surrounding Indianapolis areas and those individuals passing through town. The kitchen was named in memory of Kenneth Butler, once a fire chief in Greenfield, who dedicated his time to helping those in need through truck-stop ministries, prison ministries, nursing home ministries and lending a hand to homeless individuals. The original vision for the kitchen was to be a safe haven for people who need to fulfill the basic human need of obtaining food without having to meet certain requirements and without any judgment on their personal situation. Kenneth Butler Memorial Soup Kitchen is carrying that vision through to this day and preserving it for the future. The kitchen is pleased to be able to serve food to about 100 people per day in a clean, welcoming and friendly atmosphere. *According to Jill Ebert, KBMSK Executive Director, "Everyone should feel like they are coming to Grandma's house."*

Families First, a family-focused and community based organization, strives to preserve and strengthen families in times of crisis, change and growth through counseling, education and support. The quality care provided through its programs helps Central Indiana families move



toward their goal of a strong and healthy family. The organization offers a comprehensive array of services ranging from family counseling to substance abuse treatment, and from eldercare services to educational and self-sufficiency programs. *The Families First Hancock County office helped 227 individuals in 2010 alone, and 90% of individuals completing the Alternatives to Domestic Violence Program reported a reliable understanding of the cycle of violence, while 98% reported they were violence free.*

In 2010, HCCF was pleased to award Families First a grant from the Hancock County Enrichment Fund. The funds will support the organization's Alternatives to Domestic Violence program in Hancock County, specifically the male perpetrators group. Many participants of this program are struggling with poverty, illiteracy and substance abuse and often have grown up in abusive or neglectful families. Many participants lack support systems, and research has shown that all of these factors may put individuals at risk of abusive behavior. The Alternatives to Domestic Violence program helps perpetrators and their families stop their abusive behaviors with current and future partners by understanding the real reasons behind their behaviors and by building self-esteem. One of the program's main goals is to interrupt the transfer of violent relationship patterns from one generation to the next. The Foundation is fortunate to work with Families First on such an important initiative in this community.

For 19 years, funds have been established with the Community Foundation through the generosity of caring citizens. Funds continue to grow through proper stewardship of investments, protection from inflation, and continued financial support. Mr. Rollin Cossey stunned the Community Foundation with an estate gift totaling over \$1 million. *When meeting with Mr. Cossey to discuss his philanthropic intentions, HCCF learned that he had come to consider Hancock County his second home. He loved the people here and had come to know many community members through his professional acquaintances, shopping, and dining*

venues. As a lifetime resident, businessman, and clergy member in Marion County, Rollin knew many great philanthropists including Eli Lilly himself, with whom he dined regularly. Through these relationships, he came to understand the meaning of impact in relation to need, that is to say, need from a philanthropist’s perspective. He knew that while Marion County has a half billion dollar community foundation and many private, family, and corporate foundations, Hancock County has only two: The Community Foundation and the Hospital Foundation. Because Mr. Cossey’s gift is discretionary, the fund named in he and his family’s honor will allow HCCF to address a broad range of needs through proactive and competitive grant-making to Hancock County nonprofit organizations and programs that serve our community’s people. He asked but one thing. . .that preference be given, when possible, to programs helping underprivileged children. The generous Mr. Cossey was an HCCF Legacy Society member.

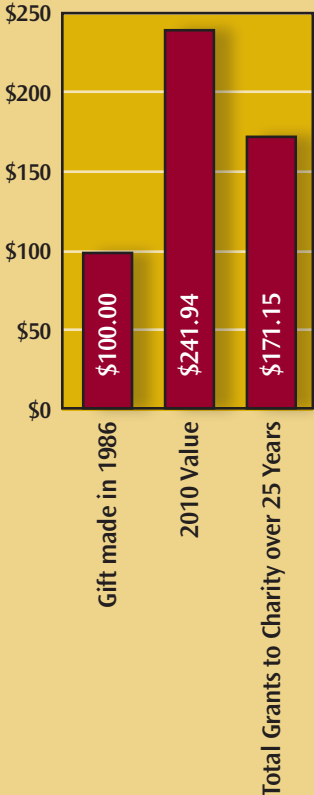
In May, HCCF received a contribution of coins for the Hancock County Enrichment Fund from Mt. Vernon Middle School Students.



Their \$64.72 gift is the perfect example of how people of all ages and means can invest in the future of our great county. Students made the gift after celebrating Hancock County’s Birthday as part of HCCF’s initiative to encourage citizens to grow their appreciation for the community in which they live, its rich history, and the desire to strengthen its future through giving and service (see more page 21). *“I didn’t even know Hancock County had a flag and I never really thought about it having a birthday! Learning more about our county helped me understand how important it is to make sure it will be here for my own kids someday,”* exclaimed an enthusiastic MVMS student. The gift of \$64.72 will be invested permanently with those of others and the income generated will help provide grants to Hancock County organizations in the future.

THE PLANNED GIFT OF LAND

Through Lewis Strahl's planned estate gift, HCCF received his gift of land. In his will, *Lewis asked that the land be retained by HCCF for ten years and the income generated from crops be divided equally between two endowments: one for New Palestine United Methodist Church and one to create scholarships for students graduating from New Palestine High School.* HCCF carefully stewards the non-tillable acreage, a house, barn and pasture. The house, identified as unrentable due to extensive remodeling costs, electrical/plumbing code violations, asbestos, and termites, was donated to Greenfield Fire Department for a controlled burn. Doing so allowed the fire department an opportunity to train for real-life situations and saved the costly impact the house would have on the philanthropic intent of the two endowment funds. The barn has been repaired and the pasture rented for livestock. The tillable property is cash rented. What a privilege to steward this wonderful gift of farmland!

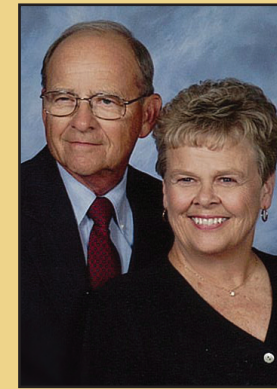

The Hancock County Community Foundation Option for Giving:

The Hancock County Community Foundation is a flexible tool that allows donors to perpetuate their planned gifts, as opposed to leaving a one-time gift, through the establishment of an endowment or by benefiting an existing endowment. Endowed gifts generate income that will provide support to your clients’ favorite charitable organizations, institutions, or causes for generations to come!

GIFT PLANS AND BENEFITS

Most of us think of giving through cash gifts, whether it be through the offering plate at church or writing checks to our favorite charities at the end of the year. Charitable gifts to funds at the Hancock County Community Foundation can actually be made in many more ways, some of which provide benefits to you or your loved ones during your lifetime. 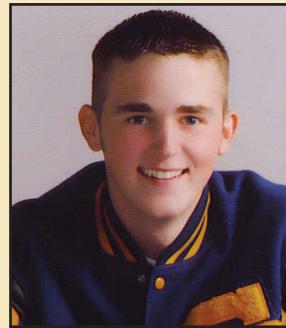

SCHOLARSHIP FUNDS REMEMBER AND HONOR

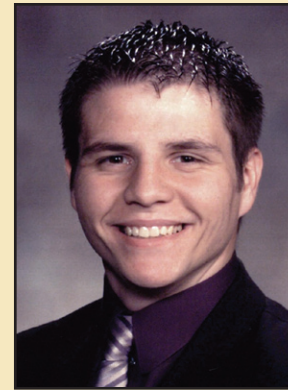

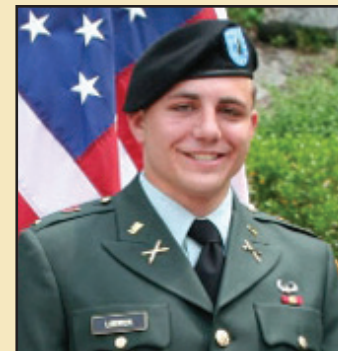

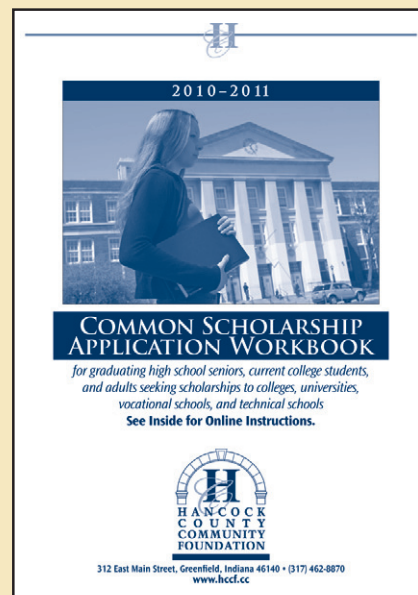

Scholarships make a tremendous difference in the lives of those students who want to continue to pursue their passion past high school without the financial burden of tuition, fees and other costs.

Since 2002, the George and Icy Vaughn Performing Arts Endowment Fund continues to promote the performing arts for the county's high school students in the form of a scholarship competition.

George and Icy were married in October 1961.

Both were active in the Western Electric Horse Riding Club. They resided in rural Vernon Township where they tended to their horses, which were mostly Palominos and Morgans. Both enjoyed gardening, canning, and preserving the foods they grew in the gardens. Icy would often write poems and sketch pictures, and George often enjoyed listening to music. After Icy passed away, George lived in a nursing home where he enjoyed the performances by local high school students who would come to sing and dance for the residents.

HOW DO I CREATE A PERMANENT FUND THROUGH THE HANCOCK COUNTY COMMUNITY FOUNDATION?

Creating a fund within the Hancock County Community Foundation is an easy process. By working with you individually, as well as your financial advisor, the staff at the Community Foundation is able to customize a fund to achieve your philanthropic goals. The Hancock County Community Foundation generally follows this process when creating a new endowment fund:

- Meets with you to discuss your philanthropic goals.
- Assists you in determining the charitable organization, institution, or cause to benefit from the fund and confirms legal compliance of all details.
- Reviews, with you, the newly created endowment fund agreement outlining the purpose of the fund and encourages you to consult with a professional advisor to confirm alliance with your overall financial plan.
- Invests the charitable endowment fund with the Foundation's endowment pool, increasing its earning power.
- Makes annual grants to your chosen charity. When the fund balance reaches \$10,000, assuming it has been invested for no less than one year, the fund may begin making grants from generated income, thus benefitting the charity for generations to come.

Scholarship Story

FOUNTAINTOWN GAS CO., INC. SCHOLARSHIP

Bob Wortman, President of Fountaintown Gas Co., Inc. sees post-secondary education as an essential element of attaining the skills needed for individuals to stimulate innovation and provide leadership for successful business.

It was foresight and leadership that led to the creation of a successful, local business in 1967. Seeing a need for natural gas service in small communities in southeast Indiana which were not being served by the existing large gas utilities, Bob, with the support of community leaders, started what is presently known as Fountaintown Gas Company, Inc.

Fountaintown Gas Co. Inc. was a small family owned gas company that had previously served the Fountaintown community from local wells with a very limited gas supply. Under new ownership, construction of a modern distribution system was started in 1967. The company, which started by serving two customers in Morristown the first year, presently serves fifteen small towns and communities in five counties including Hancock County.

Mr. Wortman believes strongly that individuals who possess vision are essential to the survival of small towns across America and, in 2010, created the Fountaintown Gas Co., Inc. Scholarship to provide educational benefit to students, served by the gas company, who strive to attain a vocational, two or four year college education. This scholarship is to be awarded to an individual who possesses a vision that, with the benefit of additional education, shows potential to impact their communities in a positive way. HCCF'S ROLE IN EDUCATION

School administrators and teachers need and desire funding to do a more effective job educating children, but communities across the United States are made up of an aging populace and are demonstrating less interest in continued tax increases to support education. This situation has been confirmed locally through a series of failed tax referendums.

Hancock County schools are beginning to understand what colleges and universities have known for decades: There are many individuals who wish to support education, and a foundation is an excellent way to begin to develop this source of philanthropy.

Since many schools and school districts want to establish a foundation but don't have the time, expertise, or finances to set one up, HCCF is serving as a vehicle to assist them in a variety of ways. HCCF stewards an endowment on behalf of the Mt. Vernon Education Foundation (MVEF). MVEF is an example of a very successful model that began its initial roots as a group of caring volunteers that turned to HCCF for guidance until they became firmly established. Eastern Hancock School Foundation is in the initial stages of formation and will use HCCF as the sole administrator of their foundation's funds. Greenfield-Central School Foundation has recently evolved out of the former Set A Good Example Foundation allowing them to expand funding opportunities throughout the entire corporation. HCCF stewards an endowment on behalf of their efforts and will play a, as yet to be determined, role in the administration of their fundraising efforts.

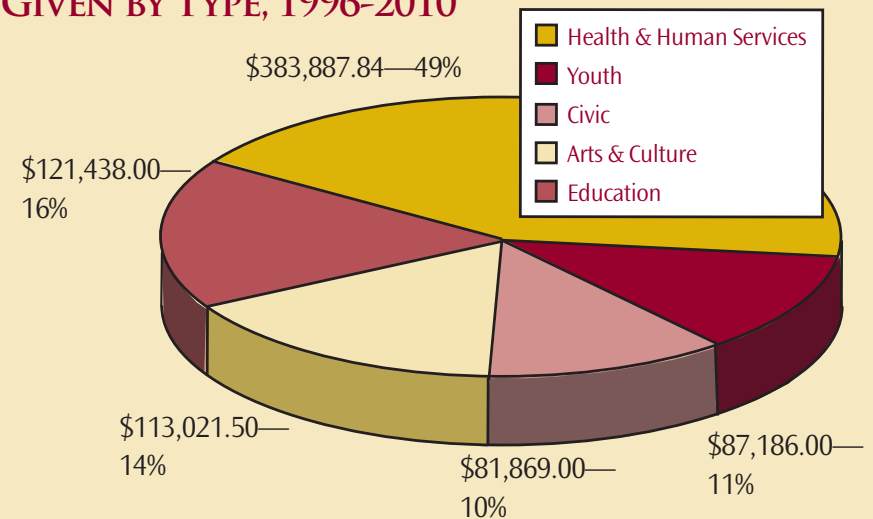
Regardless of the manner involved, HCCF is a strong supporter of educational efforts in Hancock County. Since 1996, over \$120,000 Community Enrichment grants have been made for educational purposes to both Hancock County's public and private schools. Thousands more dollars have been directed to educational endeavors through designated and donor-advised fund grants.

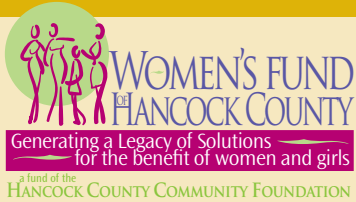

WHAT IS THE WOMEN'S FUND OF HANCOCK COUNTY?

The Women's Fund is a component fund of the Hancock County Community Foundation. It is a vehicle driven by a circle of women and girls committed to strengthening Hancock County communities. Our members are women and girls who believe that high-priority issues should be addressed thoughtfully to inspire social change and improve our quality of life for generations to come.

Knowing that combined efforts have greater impact, dedicated members pool their resources into the Women's Fund of Hancock County held at HCCF. A portion of each gift is permanently endowed, ensuring resources and creating a legacy for the future; and a portion is used annually for grants to address community needs and issues that are important to Hancock County women and girls.

Who can become a member of The Women's Fund of Hancock County?

You can! Any woman or girl over the age of 16 who supports the mission of The Women's Fund and makes an annual financial commitment at any level qualifies as a member. Girls between the ages of 10 and 16 may be sponsored by a female adult member. Membership is a one year term.

How are the grants chosen?

Each year, members are presented with a range of local issues and programs addressing those issues. Focus areas may include education, women's and/or children's health, the arts, or other issues of community interest important to women and girls. HCCF solicits grant applications from charitable organizations and the Women's Fund Grants Committee will present qualified applicants to the entire membership. A special, annual event is held for presentation of the applicants and the voting process. Each member has one vote, regardless of their membership commitment level. New families are benefiting from the services of FUSE as a result of partnering with preschools and FIRST Steps. In addition, more fathers are participating in the program.

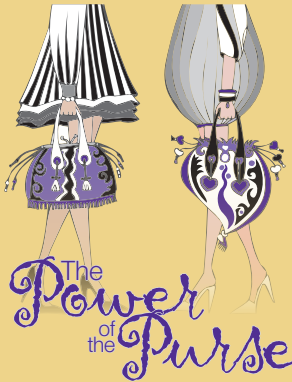
Mt. Vernon Schools

The RealCare® Infant Simulators program offered by Mt. Vernon Schools, a 2010 grantee, provides teens with a practical, measureable infant care experience. The simulators have wireless technology that create the real sounds a baby makes, such as breathing, crying, coughing, and burping. The electronic sensors simulate feeding and diaper changing, as well as, rough handling and Shaken Baby Syndrome. The infant simulators are being actively used in the Mt. Vernon High School's Child Development and Parenting Classes. Each student is required to care for an "infant" for two to three days, write an essay about the experience, keep a journal, and obtain an expense budget for the care of an infant. **Over 1000 students are in some way impacted by this program during their high school career!**

HCCF INTRODUCES "HAPPY BIRTHDAY, HANCOCK COUNTY!"

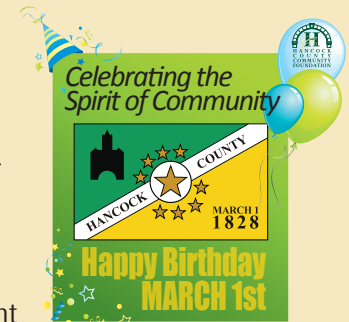

NATIONAL STANDARDS



The Hancock County Community Foundation requalified for the nation's highest philanthropic standards for operational quality, integrity and accountability in 2011. National Standards guide community foundations in establishing legal, ethical and effective operational practices that serve as blueprints for internal development and benchmarks for external assessment. The 43 National Standards required HCCF to document its policies in donor services, investment management, grantmaking and administration.

"This is similar to the Good Housekeeping Seal for community foundations," said Steve Gunderson, Council on Foundations president and chief executive officer. ***"It says that The Hancock County Community Foundation has demonstrated a commitment to operational quality, integrity and accountability."***

To receive confirmation of National Standards compliance, the Community Foundation submitted its organizational and financial policies and procedures to a rigorous peer review. Proven compliance must be submitted every five years. This is the second time such an honor has been bestowed upon HCCF, the first being in 2006.

"This certification is critically important to our donors," says Mary Gibble, HCCF's president. "When people make a charitable bequest, establish a fund or set up an annuity, they are putting their trust in us. They are counting on us to manage the investment wisely, honor their charitable wishes and, in some cases, provide lifetime income to a loved one. The National Standards confirmation says our house is in order."

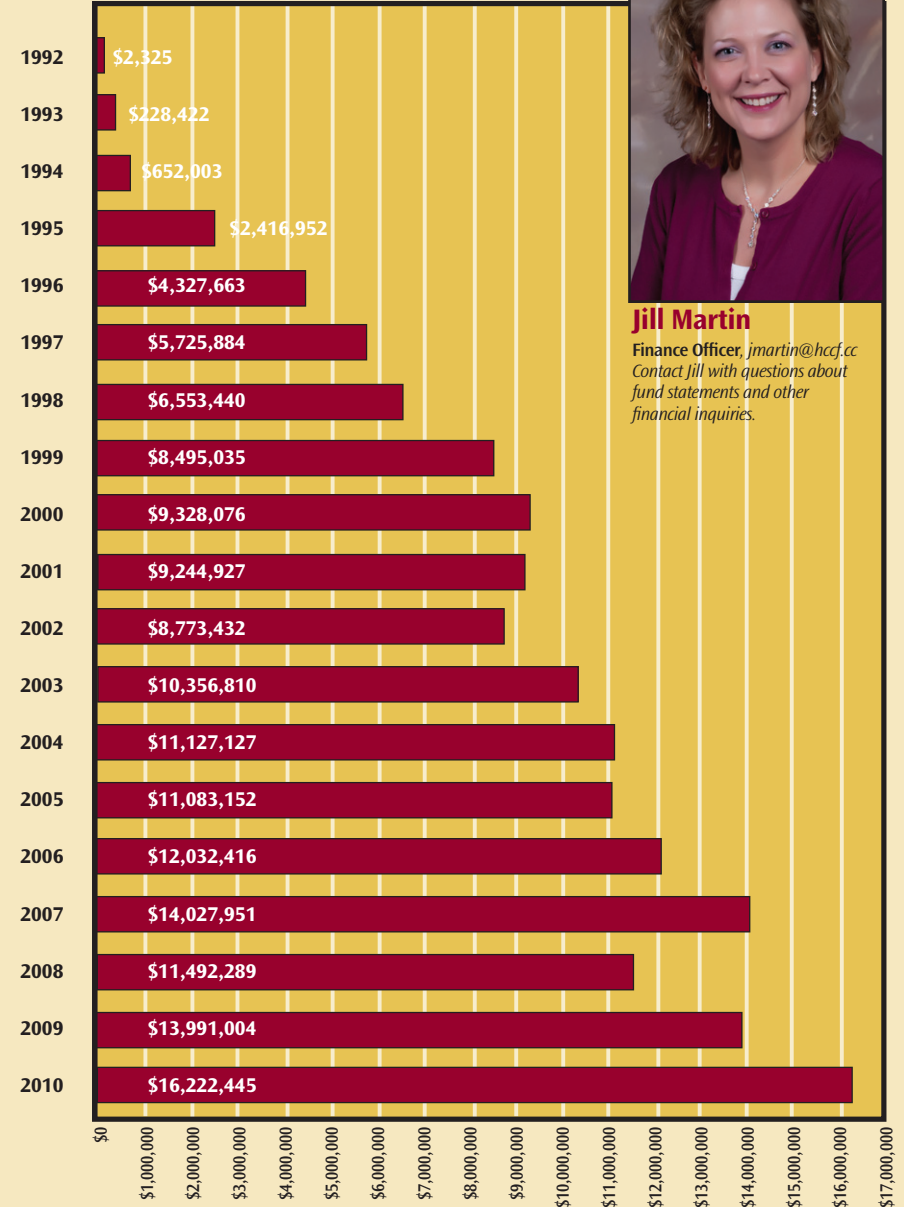

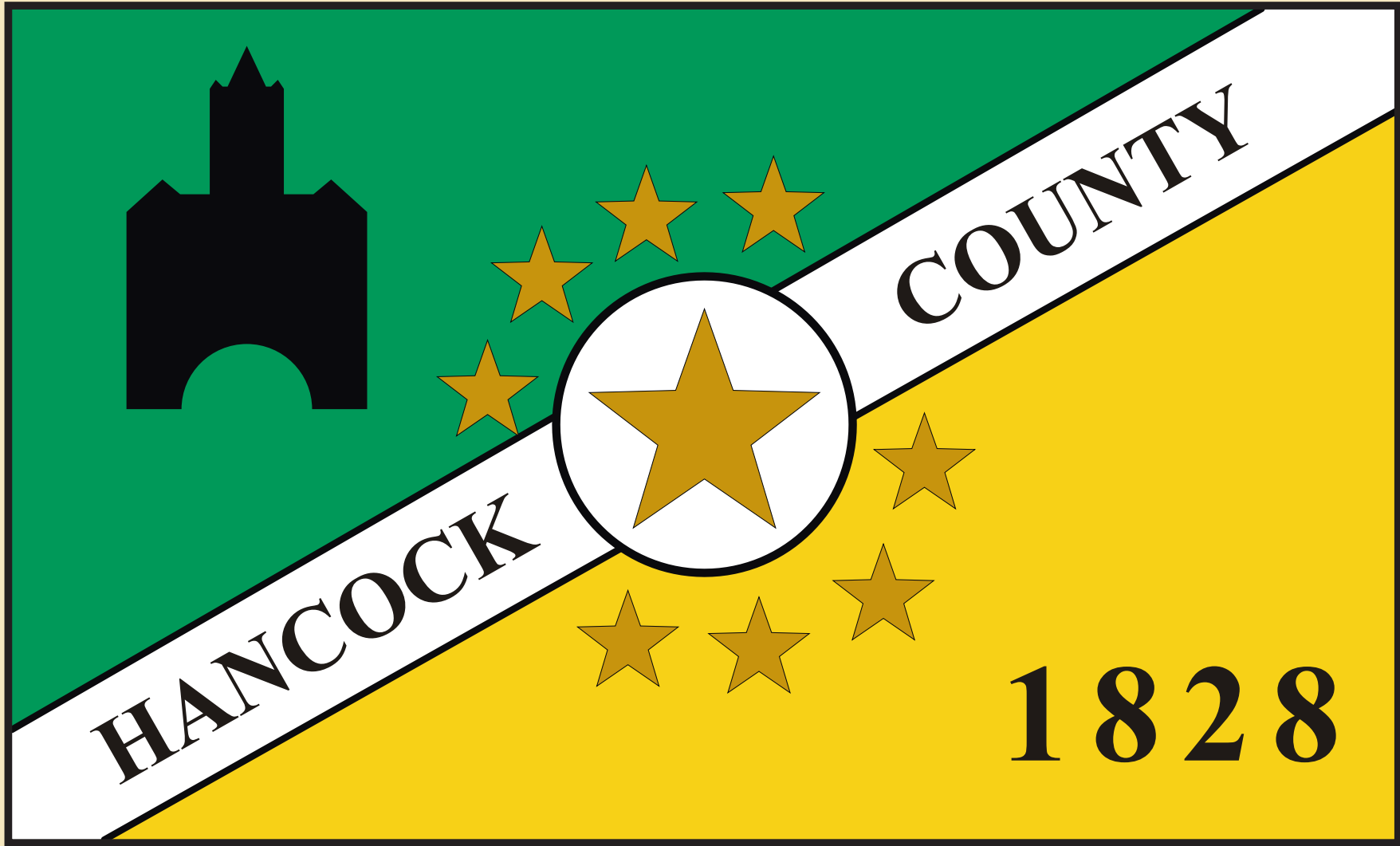
- 2004 to the present: HCCF provides philanthropic services to the Hancock County Public Library for their Brick Campaign.
